Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Please read these rules before entering the Magical Wish Holiday Sweepstakes Presented by Amazon (the "Sweepstakes"). You agree that, by submitting an entry, you will be bound by these Official Rules and you acknowledge that you satisfy all Sweepstakes eligibility requirements.

Eligibility. If you are an individual legal resident of the fifty (50) United States or the District of Columbia and are the older of eighteen (18) years of age or the legal age of majority in your state of residence at the time of entry, you are eligible to enter the Sweepstakes. Employees of Amazon Services.com LLC (the sponsor of the Sweepstakes ("Sponsor," "we" or "us")), Disney Destinations, LLC ("Prize Provider"), and our and Prize Provider's employees' immediate family members (spouses, domestic partners, parents, grandparents, siblings, children and grandchildren), and employees of our and Prize Provider's affiliates, advisors or advertising/promotion agencies (and their immediate family members) are not eligible to enter the Sweepstakes.

How to Enter. You may enter the Sweepstakes beginning at 12:00:01 a.m. (PT) on October 8, 2021 and ending at 11:59:59 p.m. (PT) on December 31, 2021 (the "Sweepstakes Period"). To enter, you must visit www.amazon.com/magicalwishesweepstakes and complete the online entry form. Limit one (1) entry per person.

Other Promotions. Please note that we may be running similar sweepstakes at the same time as this Sweepstakes. By entering this Sweepstakes, you will not be eligible to receive any prizes awarded in any other sweepstakes unless you enter each sweepstakes separately.

Prize.

One (1) Prize: Winner will receive a 2-Night stay at the *Walt Disney World*® Resort near Orlando, FL on the nights of May 30 and May 31, 2022 (the "Resort") and a *Disney Cruise Line* 3-Night Bahamian cruise from Port Canaveral, FL aboard the *Disney Wish* cruise ship with a set-sail date on or about June 1, 2022 (the "Cruise Ship") (Resort and Cruise Ship are collectively referred to as the "Vacation Package") for winner and up to three (3) guests ("Guests" and together with the winner, the "Group") consisting of:

- Roundtrip coach-class airfare for the Group between a United States gateway airport close to winner's residence (as determined by Prize Provider in its sole discretion) ("Departure Airport") and the Orlando International Airport in Florida ("Arrival Airport") (with possible layovers; airport, airline carrier and flights to be selected by Prize Provider in its sole and absolute discretion) on May 30, 2022; provided, however, if the winner resides within 200 miles of the Resort, air transportation will not be provided. If winner resides within a 200-mile radius of destination, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value;
- Roundtrip ground transportation for the Group between the Arrival Airport and the Resort (ground transfers to be selected by Prize Provider in its sole discretion) on May 30, 2022; provided, however, if winner resides within two hundred (200) miles of the Resort, ground transportation will not be provided;
- Room accommodations for the Group consisting of one (1) standard room (with a maximum of four (4) persons) for two (2) consecutive nights on the evenings of May 30 and May 31, 2022 at a Resort hotel selected by Prize Provider in its sole discretion;
- Up to four (4) 1-Day tickets with *Park Hopper*® Option for the Group for admission to the theme parks at the Resort (subject to restrictions, including, without limitation, that to enter a park, both a park reservation and valid admission

for the same park on the same date are required for Guests ages 3 and up; learn more at <https://disneyworld.disney.go.com/experience-updates/park-reservations/>;

- One (1) Disney Gift Card (for winner only) with a value of Two Hundred Dollars (\$200.00) (subject to restrictions);
- Ground transportation from the Resort to Port Canaveral, Florida on June 1, 2022;
- A 3-Night cruise for the Group with a tentative sail date of June 1, 2022 that includes the following:
 - One (1) Stateroom aboard the *Disney Wish* cruise ship (location, category, room type and all other aspects of the Stateroom to be selected by Prize Provider in its sole discretion). Maximum occupancy four (4) people;
 - All meals onboard the *Disney Wish* (except for adult-exclusive dining, bottled water, alcoholic beverages and specialty drinks);
 - Pre-paid gratuities, Taxes, and Port Expenses (as defined on <https://disneycruise.disney.go.com/>);
 - Onboard gratuities for Stateroom host/hostess, dining room server, assistant server, and head server; and
 - One (1) Castaway Cay Getaway package (as in effect at the time of sailing) for up to four (4) guests' enjoyment while visiting Castaway Cay; and
- Ground transportation from Port Canaveral, Florida to the Orlando International Airport on June 4, 2022.

The total approximate retail value ("ARV") of the Prize is Ten Thousand Dollars (\$10,000.00). Actual value of the Vacation Package may vary based on factors at the time of booking, including, but not limited to, hotel rates, airfare fluctuations and distance between departure and destination. If the actual value of the Prize is less than the stated ARV, we will not award the difference in cash or credit.

Vacation must be taken on **May 30 – June 4, 2022** for the tentative June 1, 2022 set sail date aboard the *Disney Wish* cruise ship or on such other dates as Prize Provider may select in its sole discretion for any reason whatsoever, including, without limitation, if the tentative June 1, 2022 set sail date is postponed or cancelled by *Disney Cruise Line* considering public health guidance from health authorities, such as the U.S. Centers for Disease Control and Prevention and/or appropriate government agencies or otherwise becomes unavailable for any reason. If a potential winner is unavailable to travel during the designated timeframe for any reason, the Prize will be forfeited without compensation of any kind and an alternate winner may be selected (time permitting) from among all remaining eligible entries in a random drawing

Vacation Package fulfillment and travel are subject to certain restrictions, air travel/flight availability, and hotel/room availability at the Resort and on the Cruise Ship. Travel may not occur during airline block-out periods. If the winner chooses to bring less than the allotted number of Guests, the Vacation Package will be awarded in increments suitable for the actual number of participants with no substitute prize or compensation provided to the winner. Guests of all ages are strongly encouraged to obtain passports. Winner will not receive compensation for any element(s) of the Vacation Package (including, without limitation, theme park tickets, etc.) that the winner does not accept or is unable to use for any reason, and such unused portion(s) of the Vacation Package will be forfeited. Prizes will be fulfilled by Prize Provider, or its respective prize provider agencies. If you are selected as a potential winner, Prize Provider, or its respective prize provider agencies will use the information you submit in connection with this Sweepstakes to fulfill the prize. If a threshold of COVID-19 is detected on board the cruise ship during a voyage, the voyage will be ended immediately and the ship will return to the U.S. port of embarkation, and your subsequent travel, including the winner's and Guests' return home, may be restricted or delayed. An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release, as determined by us in our sole discretion. Potential winner and potential winner's guests will be required to sign and return a Liability/Publicity Release prior to booking of any travel. Minors under the age of 18 not traveling with a parent or legal guardian must be accompanied by an adult over the age of 21 in the same stateroom. The parent or guardian of any minor not traveling with a parent or guardian must appoint an adult to have custody and control over their minor and to contract on their behalf in connection with the *Disney Cruise Line* vacation. An appointment form will be included in the document package and must be signed by parent or legal guardian prior to embarkation at the *Disney Cruise Line* terminal.

We are not responsible for: (a) lost, misdirected, late, incomplete, or unintelligible entries or for inaccurate entry information, whether caused by you or by any of the equipment or programming associated with or utilized in the Sweepstakes, or by any technical or human error that may occur in the processing of entries; (b) any printing or typographical errors in any materials associated with the Sweepstakes; (c) any error in the operation or transmission, theft, destruction, unauthorized access to, or alteration of, entries, or for technical, network, telephone, computer, hardware or software, malfunctions of any kind, or inaccurate transmission of, or failure to receive any entry information on account of technical problems or traffic congestion on the Internet or at any website; or (d) injury or damage to your or any other computer resulting from downloading any materials in connection with the Sweepstakes. We may, in our sole discretion, disqualify any individual found to be: (x) tampering with the entry process or the operation of the Sweepstakes or website; (y) acting in violation of these rules; or (z) acting in an unsportsmanlike or disruptive manner or with intent to annoy, abuse, threaten or harass any other person. If your entry is incomplete or if you use robotic, automatic, programmed or similar entry methods, your entry will be void. The authorized subscriber of the e-mail account used to enter the Sweepstakes at the actual time of entry will be deemed to be the participant and must comply with these rules in the event of a dispute as to entries submitted by multiple users having the same e-mail account. Such claims shall be resolved individually, without resort to any form of class action, and all such claims shall be limited to actual out-of-pocket costs incurred, but in no event to include attorneys' fees. You agree that Sponsor's decisions related to the Sweepstakes and all drawings are final.

Notwithstanding the foregoing, you agree that any and all disputes, claims and causes of action against Prize Provider arising out of or connected with the prize provided by Prize Provider as described above, the use thereof and/or any other action against Prize Provider in connection with or arising out of the Sweepstakes shall be resolved individually, without resort to any form of class action, and exclusively before state or federal courts within Orange County, Florida.
